RULES OF DECORUM

Enabling Motions:

- 1. That these be the guidelines for the conducting of business at this meeting:
 - a. Out of courtesy, when Presbytery is debating, all remarks shall be addressed to the moderator and shall be made from the floor.
 - b. In the interest of time and to allow as many as possible to speak, speeches will be strictly limited to 2 minutes. Persons wishing to speak should move to the appropriate microphone. So there is clarity, a speaker should begin by saying, "I speak for (or against) the amendment..." The moderator will rotate between calling on a person in favor, and then a person opposed, etc.
 - c. Remarks shall be confined to the pending question. The moderator will interrupt if in his/her judgment the speaker has drifted from the pending question.
 - d. Commissioners may not refer adversely to prior acts of Presbytery not pending now.
 - e. Remarks shall not impugn another commissioner or that person's motives.
 - f. Distribution of reports or documents shall not be done during the meeting.
 - g. Commissioners shall not disturb the meeting, by applause or verbal response to remarks made by a commissioner, or in response to a vote.
 - h. Each commissioner may speak twice on a subject but may not speak the second time until everyone who wishes has spoken.

Special Administrative Review Committee for First Presbyterian, Raton

The COM voted to request a Special Administrative Review Committee (SARC) to explore these issues with the Raton Session and Pastor. PROPOSED AMENDMENTS TO THE CONSTITUTION

Proposed Amendments to the *Book of Order*Approved by the 223rd General Assembly (2018)

Amendment 18-A. Election of Ruling Elders and Deacons On Amending G-2.0401 (Item 06-11)

This amendment originated from the Presbytery of Grace. The amendment is intended to clarify the somewhat ambiguous language regard the congregational nominating committee membership. It sets the minimum size at three members, not including the pastor. The goal of the amendment was to provide clarity.

Arguments in Support:

From rationale: Ideal for small congregations. Also provides flexibility for other churches to add more than the minimum.

From ACC: Adds clarity and is consistent with past practice.

Arguments Against:

None.

Advisory Committee on the Constitution recommended approval

Assembly Committee on Church Polity and Ordered Ministry (06) voted to approve amendment as amended by 54 – 0.

General Assembly approved approval of amendment as amended 478 – 3.

Amendment 18-B.1 Renunciation of Jurisdiction

On Amending G-2.0509 (Item 06-09, Recommendation 1)

This amendment, along with the next amendment (18-B.2), come out of the intent to clarify congregational prohibition and individual jurisdiction when a PC(USA) minister of the Word and Sacrament renounces jurisdiction while in the midst of disciplinary proceedings and then later wants to rejoin the PC(USA).

The proposed amendment originated from the Presbytery of Central Florida. The current language of G-2.0509 while intended to protect the church and its entities who have left the church by renunciation during the disciplinary process and now seeks to rejoin the PC(USA) has created a situation in which the administration of justice is impossible to carry out because a person who has renounced jurisdiction no longer holds membership in the PC(USA).

Argument in Support:

Seems reasonable and the process is understandable

Arguments Against:

No articulated opposition expressed in the Assembly Committee

ACC: See discussion in bulletin at pages 4-5.

The new language would eliminate any requirement of membership by the former MWS before application for restoration

The term "application" to the presbytery is not defined and there are no criteria for considering such an application

Contrary to a 1989 authoritative interpretation that specifies that one who renounces jurisdiction and seeks to return to ministry in the PC(USA) shall first come under the jurisdiction of the church as a member of a particular church and then initiate the process and procedures for Preparation for Ministry. The new language would not require membership in any church.

A MWS who has renounced jurisdiction may not be restored to ordered ministry because the person voluntarily acted to negate that status, especially where a disciplinary case was pending and has refused to be subject to church discipline.

Office of General Assembly: This change should be referred to the task force working on a revision to the Rules of Discipline.

Members of the Safe and Sacred Space Task Force: The second paragraph increases risk of abuse within the church by allowing a former minister to return to ministry within the PC(USA) with an easier path of restoration where any prior allegations of abuse are without resolution.

Advisory Committee on the Constitution recommended disapproval Assembly Committee on Church Polity and Ordered Ministry (06) voted to approve the amendment as amended by 54 – 3

General Assembly approved the amendment as amended by 466 - 7

Amendment 18-B.2 Renunciation of Jurisdiction

On Amending D-10.0401d (Item 06-09, Recommendation 2)

This amendment, along with the prior amendment (18-B.1), come out of the intent to clarify congregational prohibition and individual jurisdiction when a PC(USA) minister of the Word and Sacrament renounces jurisdiction while in the midst of disciplinary proceedings and then later wants to rejoin the PC(USA).

The proposed amendment originates from the Presbytery of The Twin Cities Area. The rationale argues that the current provisions of D-10.0401d allow former teaching elders to rejoin the church after renouncing jurisdiction but does not require them to face accusations

until sometime in the future when they themselves choose to come forward by self-accusation.

Arguments in Support:

Current G-2.0509 and D-10.0401d are inconsistent with the purposes of the Rules of Discipline set forth in the Preamble and is unfair to victims who are never sure when the accused is going to choose to resume the disciplinary process. The current rules now "punishes victims".

Arguments Against:

ACC: This change should be referred to the task force working on a revision to the Rules of Discipline.

Advocacy Committee for Women's Concerns: Supports the changes but they are inadequate.

Office of General Assembly: This change should be referred to the task force working on a revision to the Rules of Discipline.

Advisory Committee on the Constitution recommended disapproval

Assembly Committee on Church Polity and Ordered Ministry (06) voted to approve the amendment as amended by 54 – 3

General Assembly approved the amendment as amended by 466 – 7

Amendment 18-C Officers

On Amending G-3.0104 (Item 06-16)

This amendment comes from the Presbytery of Western North Carolina. Since 1954, the Johnson Amendment to the United States tax code prohibits charitable organizations, including churches, from endorsing or opposing political candidates. Action has been taken to loosen this prohibition. This amendment would offer explicit guidance to governing

bodies or those in leadership positions regarding endorsing or opposing candidates running for political office.

Arguments in Support:

Preferable to passing this amendment after the Johnson Amendment is removed by Congress.

Get in front of possible changes to Johnson Amendment

Assists in protecting 501(C)(3) status

In plenary: Divisive times and this amendment enables time honored separation of church and state

In plenary: Will not interfere with MWS speaking to social policy issues Arguments Against:

Presbyterian sensibilities tells us not to advocate for or against a political candidate

Specific prohibition implies the absence of authority to speak from the pulpit with the authority of scripture

ACC: This amendment would reverse long-standing foundational principles of our denomination and have long-reaching effects on the church in the areas of individual discernment and diversity of religious belief, formation of conscience in community, separation of church and state, responsibility for involvement in public life and endorsement or opposition to political candidates. See discussion in bulletin at pages 8-10.

Advisory Committee on the Constitution recommended disapproval

Advisory Committee for Social Witness Policy recommended approval after making a proposed amendment which was not adopted by the General Assembly

The Assembly Committee on Church Polity and Ordered Ministry (06) voted the proposed as amended 31-24.

The General Assembly approved the amendment as amended by 370-99.

Amendment 18-D Membership of Presbytery

On Amending G-3.0306 (Item 06-05)

This proposed amendment originates from the Presbytery of Tropical Florida. This amendment would provide clarity to minister members seeking permission to labor within the bounds of a presbytery beyond their current membership.

Arguments in support:

Clarifies laboring outside bounds of presbytery of membership Brings back language from old Book of Order (2009-2011)

Arguments against:

None

The Advisory Committee on the Constitution recommended approval The Assembly Committee on Church Polity and Ordered Ministry (06) voted the proposed as amended 52-1.

The General Assembly approved the amendment as amended by 442-13.

Amendment 18-E Pastor, Counselor, and Advisor to Its Pastors and Congregations

On Amending G-3.0307 (Item 16-02)

The proposed amendment originated from the Presbytery of Santa Fe. The proposed amendment seeks to clear up repetitive wording in G-3.0307.

Arguments in Support:

Correcting language

Limited discussion

Arguments against:

None.

The Advisory Committee on the Constitution recommended approval for this amendment because the existing language introduced the term "pastor" and was cutting off all MWS not serving as installed or temporary pastors from access to COM which this amendment corrects

The Assembly Committee on Church Polity and Ordered Ministry (06) voted to approve the proposed amendment as amended by 52 - 0.

The General Assembly approved the amendment as amended by 464-3.

Amendment 18-F. Welcoming to the Table

On Amending W-4.0202 (Item 14-3)

This proposed amendment originates from the Presbytery of Grace. This amendment seeks to clarify that when children receive the Lord's Supper for the first time, the Directory of Worship is not suggesting a service such as "first communion".

Argument in support:

Rationale: the current language of "the session should provide an occasion to welcome them" could be interpreted as the need to provide a "first communion" service for baptized children or that baptized children must be of a certain age or complete certain educational requirements

ACC advises approval

Argument against:

None

The Advisory Committee on the Constitution recommended approval
The Assembly Committee on Theological and Church Growth Issues and
Institutions (14) voted to approve the proposed amendment by 50-1.

The General Assembly approved the proposed amendment by voice vote.

Amendment 18-G. Disciplinary Offense

On Amending D-2.0203b (Item 06-04)

This proposed amendment originates from the Presbytery of North Alabama. This amendment is intended to insure that violations of a council's sexual misconduct policy are contrary to the Scriptures or the Constitution and may be address through the disciplinary process.

Arguments in support:

Rationale: Violations of a council's sexual misconduct policy must be eligible to be addressed through our disciplinary process and are by their very nature contrary to the Scriptures or the Constitution

Makes offense definition clear

No discussion in plenary

Arguments against:

Concerns were expressed prior to approval of an amendment to the overture

No concerns following approval of amendment

The Advisory Committee on the Constitution recommended disapproval because this amendment is not necessary as the Book of Order is not an enumeration of specific permitted or prohibited conduct, but rather a guide for all councils in administering their mission; listing of one offense may imply that violations of other policies are not subject to disciplinary action

The Advocacy Committee on Women's Concerns recommended approval

The Assembly Committee on Church Polity and Ordered Ministry (06) voted to approve the amendment as amended by 53 - 0.

The General Assembly approved the amendment as amended by 416-13.

Amendment 18-H.1 Time Limit

On Amending D-10.0401b (Item 06-24)

This proposed amendment originates from the Advisory Committee on the Constitution. The amendment proposes to impose a level of responsibility on persons that are not currently part of the Rules of Discipline. The amendment imposes a negligence standard for failure to respond to situations involving a reasonable risk of sexual misconduct, including the failure to report appropriately.

Argument in Support:

None.

Arguments against:

Should be referred to task force for rewriting of the Rules of Discipline

The Assembly Committee on Church Polity and Ordered Ministry (06)

voted to approve the proposed amendment as amended by 47 - 1.

The General Assembly approved the amendment as amended by 455 – 16.

Amendment 18-H.2 Time Limit

On Amending D-10.0401c(1) (Item 06-24)

This proposed amendment originates from the Advisory Committee on the Constitution. The proposed language recognizes that minors cannot consent and other persons may lack the capacity to consent.

Argument in Support:

None.

Arguments against:

Should be referred to task force for rewriting of the Rules of Discipline

voted to approve the proposed amendment as amended by 47 - 1.

The General Assembly approved the amendment as amended by 455 – 16.

STATEMENT OF FAITH:- REV. ASHER DEAN

He helped me in all my problems and difficulties in the past and he still helps me and guides me and protects me. He built up my faith and convinced me to serve Him and to the Church, and in my great confidence decided to serve Him and to the Church.

I was dedicated by my parents specially by my father (Rev. Victor Dean) to serve God and to the Church.

It is a culture of our Christian community in Pakistan that sometimes parents dedicate their children to God to serve Him. From my father's side one person in each family is a pastor because they were dedicated to God by their parents. Likewise I was dedicated to serve God.

I believe in triune God. My belief in God as a creator of all that exists, seen and unseen.

UNSEEN:- I believe that there is heaven and hell. I belief that there are angels. In the Bible we see that some of the prophets saw them but we can not see them with our natural eyes but even then by faith we believe that all these things exists.

I belief in Jesus Christ who is the Son of God. He is Fully God and fully human. Only anointed and chosen one redeemer of humanity, crucified for my sins.

I believe in the Holy Spirit as a third person of Trinity, Holy Spirit being sent by our lord Jesus Christ from the Father to testify Jesus Christ in the bible. Holy Spirit is witness directly to the individual's heart concerning Jesus and interoperates the bible and makes it easy to understand it. Holy Spirit also helps us to realize and enables us to say that Jesus is Lord. Holy Spirit lives inside those who believe in Jesus. He also convicts our hearts about how sinful we are and that we need God's forgiveness.

Baptism does not mean that it itself washes away our sins but it is a sign of our salvation in Christ applied to the believers by the Holy Spirit through faith.

Lord's Supper (EUCHRIST) is the visible sign of our ongoing communion with Christ as we are nourished by His body and blood into eternal life. Jesus is not physically present in the Lord's supper. He is spiritually present. It is the Holy Spirit who brings us in a fellowship and communion with Christ. It is publicly claiming the saving death of Christ and salvation to all those who believe that Jesus died for our sins. It is also a memorial of Jesus's death on cross. (1.Corinthions 11:23-26).

I believe in the UNIVERSAL CHURCH which expresses it's faith and belief in a living God. It reveals the power of the Father and the Son and the Holy Spirit that they can transform and save lives. The universal church is made up of all believers in Jesus Christ worldwide. All believers throughout the world are led by the Holy Spirit to glorify God through different ministries to fulfil the purpose of God.

So according to my calling and dedication to God I will be active and intentional and willing to do ministry by preaching and by doing evangelical work for Christ. I will try to attempt hard and great things to glorify God so that God will be pleased with me. My Faith Journey-Rev. Jayne L. Ruiz

I grew up in a small town on the Ohio River. There were many influences on my life such as growing up in an inter-racial neighborhood, having friends of different racial and economic backgrounds having a close-knit family and growing up in a river town.

While I attended my small Presbyterian church, most of my friends went to other churches or were unchurched. In fourth grade, I had a sledding accident where I ran into a house rupturing my spleen. Some thought that I might not survive this accident, but somehow, I did not even consider that I might die.

I remember a few months afterwards, walking up that same hill realizing a miracle had happened saying to God that I would answer God's call for my life.

I attended Eckerd College in St. Petersburg, Florida and was excited about my new-found freedom in being far away from home in a new environment. It was at College that I had a deep spiritual renewal of my life rededicating my life to God.

I was called to Seminary at Princeton Seminary. It was tough academically and the culture there was so different for me, much more traditional and rigorous especially after Eckerd where people tended to be more zany and unconventional.

Princeton was challenging in many ways. It was a learning and at times a lonely and painful growing experience. I serve in ministries such as a Chaplain at Trenton State Prison, Common Cause, a rural Church in Missouri and as a Chaplain at a Methodist University Ministry.

It was through ministry in Chaplaincy that I felt a passion for a holistic ministry and to live out a ministry that integrates discipleship, evangelism, compassion, service, and social justice.

Thus, after Seminary I pursued my Master of Social Work at Rutgers.

There I flourished and loved the diversity of people with whom I worked as a colleague and a friend. My area was Community Organizing and Planning.

I decided to live, work and study in Mexico City, Mexico. This was also tough, but I learned so much about living in a country in need, about culture, and about third world poverty and about working to become bi-lingual and bi-literate.

I have been called to a variety of ministries from the Pastor and Director of Beth-El Ministries in Florida with farmworkers, as a Social Worker and Chaplain with Hospice, as the Coordinator for Hispanic and Immigrant Ministries in Ohio, as an Interim Pastor in New Orleans, as the Designated Pastor for an English speaking as well a bi-lingual church in El Paso and in Topeka, Kansas.

My goal in ministry has been to proclaim the gospel helping people, churches and institutions to transform their lives and to transform the greater world.

I am blessed with a supportive and caring husband, Alfredo and a wonderful 29-year-old son, Cristian who works for Teach for America.

I have had the opportunity to serve a diverse group of people in a variety of ministries.

My Call to Belen - I saw an ad at the General Assembly for a Pastor to a small church close to Albuquerque desiring a pastor who could speak Spanish, and work in a small church with skills working with and connecting with the greater community. I decided to pursue this and here I am today at my new call as the Designated Pastor at First Presbyterian Church-Belen.

Statement of Faith: Rev. Jayne L. Ruiz

I believe in God Almighty, Creator, and Sustainer who continues to give meaning to my life and to my very existence and who is a refuge and strength, a very present help in times of trouble.

Humanity turned away from God. Therefore, God, desiring to reconcile all people sent Jesus into the world that the world might be saved.

Jesus Christ is the Savior and the liberator of the world representing God's unfailing love and grace. Christ brings reconciliation and redemption to this broken, sinful world.

Through Christ's death and resurrection, we have been recreated into new persons, holy, and acceptable to God though grace. Investment Policy Statement

Presbytery of Santa Fe Investment Policy

SCOPE OF THIS INVESTMENT POLICY

This statement of investment policy (IPS) shall apply to all funds belonging to the Presbytery of Santa Fe. Currently, this includes the Operating (checking) and Reserve Funds as well as the investment account and any other accounts that may be established in the future.

BACKGROUND

The Presbytery of Santa Fe is a constituent governing body under The Presbyterian Church (USA) and a not-for-profit corporation organized in 1972 for religious purposes and existing under and by virtue of the laws of the State of New Mexico. Our Presbytery is composed of 39 churches located in the geographic area of northern New Mexico. The Ecclesiastical Officers of the Presbytery consist of the Moderator, Moderator-elect, Past Moderator, Stated Clerk and Treasurer.

Our Vision Statement: The Presbytery of Santa Fe, as the Presbyterian Church (USA) in this place, is a community of congregations engaged by the Triune God in worship, education, and mission, both as congregations and as relational networks. We live into our future as a community of faith engaged in God's mission, guided by Scripture, fulfilling ecclesial responsibilities, and claiming shared values.

PURPOSE OF THIS INVESTMENT POLICY

Purpose of this Investment Policy is to:

- 1. Define and assign the responsibilities of all involved parties.
- 2. Establish a clear understanding for all involved parties, present and future, of the investment goals and objectives for the Presbytery's funds.
- 3. Offer guidance and limitations to all involved parties for the investment of the Presbytery's funds.
- 4. Establish a basis for evaluating investment results.
- 5. Manage all funds according to acceptable and prudent standards.
- 6. Establish the relevant time horizon for which the funds will be managed.

DEFINITIONS

1. "Operating and Reserve Funds" shall mean the funds held in various accounts by the Presbytery.

- 2. "Fiduciary" shall mean any individual or group of individuals that exercise discretionary authority or control over fund management or any authority or control over management, disposition or administration of the funds of the Presbytery.
- 3. "Investment Horizon" shall be the time period over which the investment objectives are expected to be met.
- 4. "All involved parties" shall include the Finance and Property Committee, staff, treasurer, and outside professionals.
- 5. "Custodian" or "Sub-custodian" is the bank, brokerage firm, Foundation, Presbyterian Investment and Loan Program, or other investment managers being used to hold and invest funds as directed.
- 6. "Investment Manager" shall mean any individual, or group of individuals, hired to manage the investments of all or part of the Presbytery's funds.
- 7. "Short term" is generally considered to be two years or less.
- 8. "Long Term" is generally considered to be greater than five years.
- 9. "Securities" shall refer to the marketable investment securities which are defined as acceptable in this Policy.

DELEGATION OF AUTHORITY

The Trustees of the Presbytery of Santa Fe is a fiduciary and is responsible for directing and monitoring the investment management of funds. As such, the Presbytery is authorized to delegate certain responsibilities. These include, but are not limited to:

- 1. Finance and Property Committee, staff, and treasurer.
- 2. Custodian. The custodian will physically (or through agreement with a sub-custodian) maintain possession of securities owned by the Presbytery of Santa Fe, collect dividend and interest payments, redeem maturing securities, and effect receipt and delivery following purchases and sales. The Custodian, or sub-custodian, will provide statements of all assets owned, purchased, or sold as well as movement of assets into and out of the various accounts monthly.
- 3. Investment Manager. The investment manager has discretion to purchase, sell or hold the specific securities that will be used to meet the Presbytery's investment objectives. Managers will be held responsible and accountable to achieve the stated objectives.
- 4. Additional specialist such as attorneys, auditors, actuaries, retirement plan consultants, and others may be employed by the Presbytery to assist in meeting its responsibilities and obligations to administer assets prudently. If such outside experts employed are also deemed to be fiduciaries, they must acknowledge such in writing. All expenses for such experts must be customary and reasonable, and will be borne by the Presbytery when deemed appropriate and necessary.
- 5. The Finance and Property Committee shall monitor investment decisions and results.

GENERAL INVESTMENT PRINCIPLES

Investments shall be made solely for the interest and benefit of the Presbytery of Santa Fe.

- 1. Presbytery shall work within the guidelines of Mission Responsibility Through Investment of the Presbyterian Church (U.S.A.).
- 2. Investments shall be managed in the best interest of the Presbytery.
- 3. Investments shall be diversified so as to minimize risk of principal.
- 4. Presbytery's cash assets shall be invested with care, skill, prudence, and diligence under the circumstances then prevailing. The investment horizon for cash investments is not to exceed two years.
- 5. Cash is to be managed conservatively, by investment in short term cash equivalents to provide safety, liquidity and return.

INVESTMENT OBJECTIVES

In order to meet its needs and obligations, the investment strategy of the Presbytery is to emphasize total return. That is, the aggregate return from capital appreciation and dividend and interest income.

Specifically, the primary objectives of the investment management of the Presbytery's cash assets shall be:

- 1. Liquidity. To ensure the ability to meet all expected or unexpected cash flow needs by investing in securities that can be sold readily and efficiently.
- 2. Preservation of Capital. To minimize the probability of loss of principal over the investment horizon. Emphasis is placed on minimizing return volatility rather than maximizing total return.

The primary objective of the investment management of the long-term assets shall be:

1. Balanced with growth. Growth of principal shall be the primary objective of the long-term investments (greater than 5 years) consistent with a commiserate level of risk. These returns should be greater than the rate of inflation, as defined by the CPI + 3%, net of fees, over a five year average time period.

LIQUIDITY

To minimize the possibility of a loss occasioned by the sale of a security forced by the need to meet a required payment, the staff and the Finance and Property Committee shall periodically review estimates of expected net cash flow.

To maintain the ability to deal with unplanned cash requirements that might arise, the Committee requires that adequate assets shall be maintained in cash or cash equivalents.

SPENDING POLICY

In order to provide a sustainable level of income to support the Presbytery of Santa Fe while preserving the real (inflation adjusted) purchasing power of the assets invested, the Presbytery of Santa Fe establishes the following spending policy:

- 1. 3% of the total market value of the assets invested may be distributed annually based upon a three-year rolling average of the value of such assets. Distributions shall be calculated annually.
- 2. The percentage and amount distributed shall be reviewed annually by the Property and Finance Committee of the Presbytery of Santa Fe.
- 3. Should the suggested distribution result in a reduction of the real value of the funds invested below the real value of such funds as increased or decreased for net annual appreciation (depreciation) on these assets, the Property and Finance Committee of the Presbytery of Santa Fe shall determine the percent or amount to be withdrawn. Such percent or amount shall not exceed 3% of the total three-year rolling average of the value of such assets, as previously noted.

MARKETABILITY OF ASSETS

The Presbytery requires that all of Presbytery's cash assets be invested in liquid securities, defined as securities that can be transacted quickly, efficiently and with minimal loss of principal.

- Common Stock
- American Depository Receipts (ADR) of Non-U.S. Companies
- Mutual Funds (Domestic or International)

- Exchange Traded Funds-ETFs (Domestic or International)
- Real Estate (Publicly Traded REITs)
- 4. Presbyterian Investment and Loan Program notes

Prohibited Investments

Prohibited investments included, but are not limited to the following:

- 1. Commodities and Futures contracts
- 2. Private Placements
- 3. Options
- 4. Limited Partnerships
- 5. Venture-Capital investments
- 6. Derivatives
- 7. Individual high yield corporate bonds

Prohibited Transactions

Prohibited transactions include, but are not limited to the following:

INVESTMENT MANAGER PERFORMANCE REVIEW AND EVALUATION

The Investment Manager shall be reviewed every three years regarding performance, personnel, strategy, research capabilities, organizational and business matters, and other qualitative factors that may impact their ability to achieve the desired investment results.

The Presbytery office will be mailed monthly statements indicating the cost basis and current value of all investments. Statements will include all transactions affecting assets within the portfolio and additions or withdrawals to the endowment.

Performance reports generated by the Investment Manager shall be compiled at least quarterly and communicated to the Finance and Property Committee for review and comparison against commonly accepted performance benchmarks. Consideration shall be given to the extent to which the investment results are consistent with the investment objectives, goals and guidelines as set forth in this statement. The Committee intends to evaluate the portfolio over at least a three-year period, but reserves the right to terminate an Investment Manager for any reason including the following:

- 1. Investment performance that is significantly less than anticipated given the discipline employed and the risk parameters established, or unacceptable justification of poor results.
- 2. Failure to adhere to any aspect of this statement of investment policy, including communication and reporting requirements.
- 3. Significant qualitative changes to the investment management organization.
- 4. Unacceptable customer service

INVESTMENT POLICY AND PERFORMANCE REVIEW

To assure continued relevance of the guidelines, objectives, financial status and capital markets and expectations as established in this Investment Policy, the Finance and Property Committee shall review the investment policy and performance, at least annually, and make recommendations to the Presbytery Council.

Background Information for Advocacy Work

Introduction

Congress has completed its committee organizing and has begun in February the work on its legislative agenda. On February 8, U.S. Senators Klobuchar (MN), Enzi (WY), and Leahy (VT) introduced the *Freedom to Export to Cuba Act* that would effectively lift the Cuba trade embargo. The Act would repeal legal restrictions against doing business with Cuba including the original 1961 authorization for establishing the trade embargo, along with other restrictive statutes that prohibit transactions between U.S.-controlled firms and Cuba, as well as direct shipping. Rep. Crawford (AK) believes a Cuba trade bill has a better chance of passage in this Congress than in previous years. Rep. Jim McGovern gave a speech on the House floor on February 9 calling for a new U.S. policy toward Cuba and warning of the dangers of not waiving provisions of the 1996 Helms-Burton Act regarding investments and property expropriation.

In other words, legislative action is gearing up – and CPN advocates must as well! The Office of Public Witness with the September delegation of ecumenical church representatives is also currently in process of identifying and prioritizing Members and Senators for monthly visits. Some CPN members have asked for general background information on the Presbyterian Church in Cuba, church partnerships, and U.S. embargo legislation – in addition to the detailed LAWG *Cuba Advocacy Tool Kit* – in order to be better prepared for meetings with Congressional staff, Representatives, and Senators. This background paper provides that general information.

The Presbyterian Church in Cuba

The Presbyterian-Reformed Church in Cuba (PRCC) is thriving, alive and well! It now has 32 "organized" churches with 12,342 baptized members (1,894 active membership), in addition to 21 mission and house churches. There are 34 ordained Presbyterian pastors, 8 of whom are retired and 13 of whom are women. Cuban Presbyterian pastors have also worked or studied outside Cuba, e.g., in Geneva with the World Council of Churches. The PRCC was a founding member of the Cuban Council of Churches, and several Presbyterian pastors have served as President of the Council. The PRRC with the Episcopal Church in Cuba owns and operates the Evangelical Theological Seminary in Matanzas with more than 600 students in different programs. Eleven of these students are candidates to become pastors. The PRCC is actively involved in the World Council of Churches (WCC), the World Communion of Reformed Churches (WCRC), the Latin American Council of Churches (CLAI), and the Association of Presbyterian and Reformed Churches in Latin America (AIPRAL).

The Presbyterian Church in Cuba began in 1890, with support from the Presbyterian Church USA and mission workers in the early 1900s. The Presbytery of Havana of the PC(USA) was organized in 1904 and placed under the Synod of New Jersey. In 1967 the Presbyterian Church in Cuba became autonomous and was constituted as the Presbyterian-Reformed Church in Cuba.

U.S.-Cuba Presbyterian Church Partnerships

In 1985 the PRCC invited the Presbyterian Church (USA) to develop together a Mutual Mission Agreement that was adopted by both General Assemblies in 1986. This Agreement authorized formation of partnerships between presbyteries of the two Churches. The Agreement was later amended to allow partnerships between congregations. Since then, 15 U.S. presbyteries and synods and more than 30 congregations have formed partnerships with Cuban presbyteries, congregations, and the seminary in Matanzas. In 2018 the Mutual Mission Agreement was updated and adopted. PC(USA) church partners visit Cuban partners regularly and have the opportunity to participate in church activities and to observe the growth and challenges Cuban church members confront, many of these challenges—particularly economic—a result of U.S. embargo policy. As frequently as possible, PC(USA) and its churches host Cuban pastors, church officers and members to the U.S. to participate in partner Presbyterian Church activities. The foundation of the partnerships is to support each other, learn from each other, and walk together in faith in Christ's name.

U.S. Cuba Policy

History:

The U.S. embargo against Cuba is a complex mix of legislative acts, executive orders, and interpretive regulations. President Eisenhower in 1958 prohibited arms sales during the conflict between Castro's rebels and the Batista regime. In 1960 the Eisenhower Administration reduced sugar imports from Cuba and canceled U.S. exports of oil to Cuba. Following a wave of Cuban nationalizations of US properties, the Eisenhower Administration severed all diplomatic relations with Cuba in January 1961, and the partial trade embargo with Cuba continued under authority of the *Trading with the Enemy Act 1917*. Following the failed U.S. Bay of Pigs invasion in April 1961 (planned by Eisenhower), the *Foreign Assistance Act 1961* prohibited aid to Cuba and authorized the President to impose a complete trade embargo against Cuba. In 1963 President Kennedy extended the embargo by Executive Order to include travel restrictions and all trade except non-subsidized food and medicines.

U.S. citizen travel restrictions lapsed in March 1977. The regulation was renewable every six months, but President Carter did not renew it, and the regulation on spending U.S. dollars in Cuba was also lifted. President Reagan reinstated the trade embargo in 1982 but travel restrictions applied to business and tourist travel, not to government officials, professional researchers, or persons visiting close relatives. This was modified by President Bush in 2004 with the Cuban Assets Control Regulations. Regulations do

not prohibit U.S.-citizen travel to Cuba *per se*, but rather prohibit and control transactions of money and gifts. Travel requires an issued license from the U.S. Treasury Department.

The embargo was reinforced in October 1992 by the *Cuban Democracy Act* and the 1996 *Cuban Liberty and Democracy Solidarity Act* ("Helms-Burton Act"), the latter affecting property in Cuba confiscated by the Cuban Government and penalizing foreign companies doing business in Cuba. The embargo was relaxed in 2000 by Congress (*Trade Sanctions Reform and Export Enhancement Act*) to allow the sale of agricultural goods and medicines. In 2004 President Bush tightened travel restrictions (eliminating the humanitarian travel category) generally and for Cuban Americans visiting family in Cuba. President Obama restored diplomatic relations and in 2015 loosened travel restrictions to Cuba. Visits for tourism, unless under a specific license, remain banned. Each piece of embargo legislation can be changed only by Congress.

Current U.S. Policy:

In 2017 the Trump Administration again tightened travel restrictions to Cuba, but did not reverse all progress made by the Obama Administration, e.g., commercial flights and cruise ships to Cuba continue. The increased restrictions, however, have had a significant negative impact on US. tourism to Cuba and therefore on the economic condition of Cubans who relied on this business. The Trump Administration is considering putting Cuba back on the list of state sponsors of terrorism (having been rescinded in 2015). The latest tightening under consideration is **Title III** of the **Helms-Burton Act** that "allows Cuban exiles or their families and a few U.S. companies to seek remedies in U.S. courts for properties they lost in Cuba due to nationalization" by the Castro Government. Past Presidents have waived this Title due to the cost and time and effects of lawsuits in courts and for the negative impact on US foreign partners. In January 2019, the State Department announced that it is considering not waiving Title III, and the final decision will be made in late 2019.

The Trump Administration also has effectively closed U.S. Embassy Consular operations due to the unresolved illnesses caused to U.S. personnel in Havana (both U.S. and Canadian). This has effectively stopped Cubans from traveling to the U.S. as the rules now require them to travel to a third country to obtain a U.S. visa, a costly process that does not necessarily guarantee a granted visa.

Presbyterian Church Advocacy for the Cuban Church and People

The negative effect of the U.S. embargo on Cubans and the Church in particular has been a consistent "current concern" of the PRCC expressed by Cuban church representatives. Most recently, the lack of access to U.S. visas has stopped church partnership exchanges and all Cubans wishing to visit family in the States for those Cubans requiring a visa. U.S. Presbyterians on congregational visits have heard repeated stories of the hardships endured by those Cubans known to them personally. The continued involvement of PC(USA) members with Cuban church members experiencing the effects of the U.S. embargo gives U.S. partners an unusual understanding of the impact of the embargo and

of the closed U.S. Consular Section in Havana, especially on the most vulnerable. As partners with Cubans Christians, we have a responsibility to make known to our legislators the need to change this failed policy.

At its 2018 annual meeting, the PC(USA) Cuba Partners Network agreed that advocacy is an inherent part of mutual mission, and that church partners will henceforth incorporate advocacy into their partnership program for improved U.S. policy toward Cuba, specifically lifting the embargo and restoring U.S. visa operations in Havana as a central tenet of its partnership role.

As partners with Cuban Presbyterian Churches and Presbyteries, U.S. church advocates should seek to meet with, or write to, Congressional staff, Members, and Senators focusing on the following:

- Provide information and greater understanding of the thriving church in Cuba using the experience and knowledge of being with the Cuban churches and people. Relay the stories of your visits, your impressions of living conditions, the energy, vitality, and needs of the faith-based communities.
- Offer to meet before a trip to Cuba to inform them of the partnership, your concerns, your impressions of Cubans' situations. Offer to meet with staff or Members after your trip to report on current conditions, observations on the economy and political situation (e.g., the new constitution being considered).
- Urge Congress to press the Administration to continue the waiver of Title III of Helms-Burton.
- Urge Members to press the Administration NOT to reinstate Cuba on the list of state sponsors of terrorism.
- Urge Members and Senators to support the introduced bills that would lift the U.S. trade embargo and restrictions on doing business in Cuba.
- Urge reopening of the U.S. Consular section explaining the hardship and expense this imposes on Cubans needing to visit the U.S., and especially on church partnerships that now have not been able to host Cuban pastors and church members as part of the partnership program.
